## 1. Approval of Minutes

#### 2. Agency Strategic Plan – Annual Report Overview (Darrell Payne)

The Strategic Plan Annual Report shows progress toward improving service quality in high equity areas identified in the Equity Index, expanding ridership by attracting new riders to mobility-oriented options, and establishing fare structures that support greater regional access to transit ridership for all income levels while minimizing negative revenue impacts.

# 3. Quarterly update: University Line BRT Project (Amy Silbermann)

The University Line BRT project is continuing with Phase 1 work in Downtown Pittsburgh currently under constructions and expected to be completed by Spring 2025, with the installation of the five transit stations.

Phase 2 work in the Uptown and Oakland neighborhoods are advancing toward contractor selection, with construction into 2027.

#### Updates:

## A. Traffic Signals

- On October 7, PRT's contractor began activating new traffic signals.
- The contractor will move through the downtown loop, one intersection at a time, activating the new signals. Each is expected to take one or two days.
- The University Line project includes 35 new traffic signals in downtown Pittsburgh.

## B. Changes in Traffic Flow

- At the end of October, PRT's contractor will begin installing the updated roadway paint lines for the ultimate configuration of travel lanes on Fifth and Sixth Avenues in downtown Pittsburgh.
- This will NOT include the red "Bus Only" lane markings these will not be installed until spring 2025.
- Fifth Avenue between Sixth Ave and Wood St will be two lanes eastbound and one (eventually bus) lane westbound
- Fifth Ave between Market St and Liberty Ave will be one lane in each direction

#### C. Safety and Accessibility Improvements

- 16 intersections will be modernized to include:
  - ADA compliant curb ramps and crosswalks
  - Accessible pedestrian signals/push button activators
  - o Illuminated pedestrian countdown signals
  - o New traffic signals and intersection lighting
  - o expanded sidewalks and shorter crosswalks in some locations
- PRTX stations will have an ADA compliant loading zone.

With no further business, the Planning & Stakeholder Relations Committee meeting was adjourned.
