Transit Survey Promotion

Official Rules

NO PURCHASE NECESSARY TO PARTICIPATE. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCE OF WINNING THE DRAWING. VOID WHERE PROHIBITED.

1. TIMING

The Pittsburgh Regional Transit (PRT) Survey Promotion (or "The Promotion") runs from March 27, 2023 at 12:00 a.m. Eastern Time ("ET") and ends on April 30, 2023 at 11:59 p.m. ET ("Promotion Period"). Sponsor's computer is the official time keeping device for The Promotion.

2. ELIGIBILITY:

The Transit Survey Promotion is open only to legal residents of the fifty (50) United States (including the District of Columbia; excluding Rhode Island) who are at least eighteen (18) years old at the time of entry. Employees of the Pittsburgh Regional Transit (PRT) and Campos Research as well as the immediate family (spouse, parents, in-laws, siblings, and children) and household members of each such employee are not eligible. Void where prohibited by law. The Transit Survey Promotion is subject to all applicable federal, state, and local laws and regulations. Participation in the Transit Survey Promotion constitutes participant's full and unconditional agreement to these Official Rules and by the Sponsor's decisions, which are final and binding in all matters related to The Promotion. Winning a Voucher or Prize is contingent upon fulfilling all requirements set forth herein. The Promotion shall be construed pursuant to the laws of the Commonwealth of Pennsylvania. The potential winner of The Prize may be required to execute and return, prior to and as a condition of receiving The Prize, an affidavit of eligibility and liability release and, except where prohibited by law, a publicity release.

31 Day Rider Pass—Pittsburgh Regional Transit (PRT) will present one (1) Pittsburgh Regional Transit (PRT) 31-Day Rider Pass ("Prize") to one winner during a random drawing ("The Drawing") of eligible entries which will occur on May 15, 2023. No purchase necessary. Limit

one entry per person. There are two ways to enter: (1) eligible participants must either complete the Transit Survey in accordance with one of the methods set forth above, or (2) eligible participants must mail a stamped, hand-printed 3" x 5" index card including your name, address, age, residential telephone number, and email address (if any) to:

All mail-in entries must be postmarked during the Promotion Period and must be received no later than May 8, 2023.

For All Entries for The Promotion: You may enter one (1) time during the Promotion Period. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different Twitter accounts, email addresses, identities, registrations and logins, or any other methods will void all of that entrant's entries and that entrant will be disqualified. Use of any automated system to participate is prohibited and will result in disqualification of entrant and voiding of all of entrant's entries.

4. SELECTION:

Sponsor will randomly select one (1) potential winner of the drawing for the 31-Day Rider Pass (the Prize") and three (3) alternate potential winners from all eligible entries received or postmarked during the Promotion Period in accordance with the above. The drawing will take place at Transit Survey Promotion, c/o Planning and Development Department- 345 Sixth Avenue, 3rd Floor, Pittsburgh, PA 15222 on May 15, 2023. Potential winner need not be present. The potential winner will be notified by mail within ten (10) business days following the drawing date. If a potential winner has not reached the age of majority in his/her state of residence, then the prize will be awarded in the name of his/her parent or legal guardian. If the potential winner fails to sign and return the Letter of Redemption which will accompany Pittsburgh Regional Transit (PRT)'s mail notification within twenty (20) days from the original mailing date of Pittsburgh Regional Transit (PRT)'s mail notification, an alternate entrant will be selected in his/her place from the three (3) alternate potential winners in the order in which the alternate potential winners were selected. Alternate potential winners must meet the same requirements to claim the Prize. If the Prize remains unclaimed following notification to the one (1) potential winner and the three (3) alternate potential winners, the Prize will remain un-awarded. Prize will be fulfilled 8-10 weeks after winner confirmation.

5. VOUCHER AND PRIZE DESCRIPTIONS

31-Day Rider Pass Prize—31-Day Rider Pass issued by Pittsburgh Regional Transit (PRT). Non-transferable. The pass is valued at \$97.50.

By entering, entrants agree to abide and be bound by these Official Rules and the decisions of Sponsor, which are final and binding in all matters relating to The Promotion. By entering, entrants agree to release, indemnify, defend, and hold harmless Sponsor, its affiliates, and any entity associated with the production, administration, or fulfillment of The Promotion, and each of their parents, subsidiaries, officers, directors, employees, representatives and agents, from and against any and all liability or injuries, losses, or damages of any kind, to persons or property, including death, resulting in whole or in part, directly or indirectly, from The Promotion, any Voucher or Prize won or in any promotion-related activity. Sponsor and any other entity associated with this promotion are not responsible for inaccurate or incorrect information or technical, hardware or software malfunctions, telephone failures of any kind, lost or unavailable network connections, or failed, incorrect, inaccurate, incomplete, garbled, or delayed electronic communications, whether caused by the sender, tampering, or by any of the equipment or programming associated with or utilized in this promotion that may limit the ability to participate, or by any human error that may occur in the processing of the entries in The Promotion.
